

Terms and Conditions

Information on how to enter and prizes form part of these Terms and Conditions. By participating, you agree to be bound by and comply with these Terms and Conditions.

Promoter

Competition Period

The Competition commences at 12:01 am AEST on 01 March 2026 and ends at 9.00am AEST on 27 March 2026 (Competition Period). No entry details submitted after this time will be valid.

Entry Eligibility
